

**CITY OF CORTLAND "MODIFIED SPEED LIMIT RESTRICTION"**

**Section 1. Enactment and Title.**

The City Council of the City of Cortland does hereby add Chapter 11 § 51 "Modified Speed Limit Restriction". Section 1.

**Section 2. Authorization, Purpose and Intent.**

The City has determined that it is necessary to modify its present speed limit.

**Section 3. Modified Speed Limit Restriction**

Twenty miles per hour is hereby established as the maximum speed at which vehicles may proceed on or along the following highways/streets located within the corporate limits of this City:

- A) Gram Avenue (from Groton Avenue to Prospect Terrace)

**Section 4. Effective Date.**

This Local Law shall take effect immediately upon filing in the Office of the New York Secretary of State in accordance with the Municipal Home Rule Law.


