TOWN OF DUANESBURG LOCAL LAW NO. 6 OF 2018

A LOCAL LAW AMENDING THE DOG CONTROL LAW TO EXEMPT SERVICE DOGS FROM LICENSING FEES

BE IT ENACTED by the Town Board of the Town of Duanesburg in the County of Schenectady as follows:

Section 1. Title of the Local Law.

This local law shall be entitled "A Local Law Amending the Dog Control Law to Exempt Service Dogs from Licensing Fees."

Section 2. Authorization.

This local law is enacted pursuant to the Municipal Home Rule Law and Agriculture and Markets Law

Section 3. Purpose.

The purpose of this local law is to amend section 5(H) of the Dog Control Law of the Town of Duanesburg to exempt service dogs from the licensing fees established under section 5(F) of the Dog Control Law.

Section 4. Amendments to Section 5(H) of the Dog Control Law.

Section 605 is hereby amended by adding section 5(H)(3), 5(H)(3)(a), and 5(H)(3)(b) as follows:

- (3) Service dogs are exempt from the licensing fees established in section 5(F) of this law.
 - (a) For the purposes of determining whether a dog qualifies for this exemption, the Town Clerk or authorized dog control officer shall require proof in the form of a letter from a veterinarian or doctor that sufficiently demonstrates that such dog qualifies as a service dog as defined in the New York Agriculture and Markets Law.
 - (b) Each copy of any license for such dogs shall be conspicuously marked "Service Dog" by the Town Clerk or authorized dog control officer.

Section 5 Supersession.

Pursuant to the powers granted by the Municipal Home Rule, this Local Law supersedes all provisions of the Town of Duanesburg Town Code, in so far as such statues are inconsistent

with this Local Law and any other laws or regulations of the Town of Duanesburg are superseded to the extent necessary to give this Local Law full force and effect. All other provisions shall remain the same.

Section 6. Severability.

Each separate provision of this Local Law shall be deemed independent of all other provisions therein, and if any provisions shall be deemed or declared invalid, all other provisions hereof shall remain valid and enforceable.

Section 7. Effective Date.

This Local Law shall take effect immediately upon filing in the office of the Secretary of State in accordance with Municipal Home Rule Law § 27.
