

## **VILLAGE OF MIDDLEPORT**

### **A Local Law Amending the Zoning Map of the Village of Middleport**

Be it enacted by the Village Board of Trustees of the Village of Middleport as follows:

The Zoning Code of the Village of Middleport and the Zoning Map of the Village of Middleport, as adopted at §200-5 of the Code of the Village of Middleport, and as amended from time to time, is hereby amended as follows:

A portion of the parcel located at 35 N. Main Street in the Village of Middleport and identified by Tax Map Number 86.09-1-10 described as follows:

The portion of said parcel which lies south of the southerly boundary of lands conveyed to Jacob R. Froman by Instrument No. 2013-01367 (Tax Map Number 86.09-1-11), as extended, from the centerline of N. Main St. to the easterly boundary of parcel 86.09-1-10.

is hereby rezoned from the One- and Two-Family Residential District (R-1) to More than Two-Family Residential District (R-2).

This Law shall take effect immediately upon filing with the Secretary of State.
